



## ***"Charm of the Month Club" Terms & Conditions***

***The "Charm of the Month Club" (hereinafter the "Program") is available to all Origami Owl, LLC or Origami Owl, ULC (hereinafter "O2") Independent Designers (hereinafter "ID(s)") on the terms and conditions noted below. O2 reserves the right to discontinue or alter the terms of this Program without notice.***

### ***PROGRAM OVERVIEW***

- This recurring monthly Program which launches in September 2017 runs from 12:00 a.m. CT on the first day of each calendar month through 11:59 p.m. CT on the last day of each calendar month until discontinued by O2 ("Program Period").
- All new and current IDs in good standing shall be automatically enrolled in Program. To be in good standing, IDs must be in compliance with the Independent Designer Agreement Terms & Conditions and Policies and Procedures.
- A 'month' for purposes of this Program means a business month – the time period beginning at 12 a.m. CT on the first calendar day of the month and extending until 11:59 p.m. CT on the last calendar day of the month.

### ***PROGRAM QUALIFICATION***

- An ID will be eligible to participate in Program and earn two (2) free exclusive Charms if ID generates at least 100 Personal Volume ("PV") within one month during Program Period.
- An ID may only participate in Program one time each month, regardless of the total amount of PV an ID generates during Program Period over 100 PV.
- A maximum of two (2) free exclusive Charms may be earned per ID, per month.
- PV will not be final until commissions are closed. Commissions and bonuses will be calculated by the 10<sup>th</sup> of each month for the month prior. If the 10<sup>th</sup> falls on a legal holiday or weekend, commissions and bonuses will be calculated prior to the next regularly scheduled business day.
- An ID will not earn PV on any free Charms earned through Program.
- Free Charms limited to specified Charms of O2's choosing, while supplies last.
- No returns or exchanges. No substitutions. Limited quantity. Replacements only consistent with existing warranties.

- O2 reserves the right to replace any Charm with other item of equivalent or greater value.

### ***GENERAL TERMS & CONDITIONS***

- Any unclaimed free Charms will be forfeited effective 11:59 p.m. on the last calendar day of the month in which ID is eligible to add free Charms to cart.
- Free Charms are non-transferrable. No substitutions. Free Charms have no monetary value and IDs may not exchange free Charms for a cash refund.
- By participating in Program, IDs agree to be bound by these official terms & conditions, which shall be final and binding in all respects.
- Non-compliance with these terms & conditions may result in disqualification or forfeiture of Program benefits.
- All federal, state and local laws and regulations apply, including those with respect to taxation of any Program prize. O2 shall only be responsible for rewarding IDs who earn Program benefits. O2 expressly disclaims any responsibility or liability for injury or loss to any person or property relating to the delivery and/or subsequent use of Program benefits. O2 makes no representation or warranties concerning the appearance, safety or performance of any prize awarded.
