O2 reserves the right to discontinue or alter the terms of this Promotion without notice.

OVERVIEW

- This Promotion runs from 12:00 a.m. CT on June 1, 2018 through 11:59 p.m. CT on June 30, 2018 ("Promotion Period").
- All IDs in good standing as of 12 a.m. CT on June 1, 2018 shall be automatically enrolled in Promotion. To be in good standing, IDs must be in compliance with the Independent Designer Agreement Terms & Conditions and Policies and Procedures.

PERSONAL SPONSORING POINTS ("PS")

- ¹An ID will earn four (4) PS Points if such ID personally sponsors a new ID who generates 750 PV by the end of Promotion Period.

LEVEL 1 SPONSORING POINTS ("L1S") Points

- ²An ID will earn one (1) L1S Point if any person in the ID's Level 1 personally sponsors a new ID who generates 750 PV during Promotion Period.

MENTORING LEADERS ("ML") POINTS

- An ID will earn two (2) ML Points if they personally promote up to a new Achieved Title of Team Leader or above for the first time during Promotion Period. If an ID personally promotes up multiple Levels above Team Leader during Promotion Period, such ID will earn two (2) ML Points for each new Achieved Title.
- An ID is eligible to earn two (2) ML Points each time a Designer on their Level 1 promotes up for the first time to a new Achieved Title of Team Leader or above during Promotion Period.
- A Mentor will earn two (2) ML Points if a Designer rolls-up to their Level 1 during Promotion Period and promotes up for the first time to a new Achieved Title of Team Leader or above during Promotion Period. Any ML Points earned by the previous Mentor will not roll-up to the new Mentor.
- In order to earn ML Points, a Mentor must hold a Paid-As Title that is equivalent to or exceeds the Direct Designer's new achieved Career Title (Team Leader or above) in the same calendar month the Direct Designer advances in rank. If the Direct Designer promotes up multiple Career Titles above Team Leader for the first time in one month, ML points may be earned for each new achieved title following the same rules.
- If a Level 1 ID promotes up multiple Achieved Titles during Promotion Period, ML Points may be earned for each new Achieved Title following the same rules.
- After the close of the Promotion Period calendar month, all advancements are considered final.
- If an ID advances to a new Career / Achieved Title and is deactivated or terminated, the Mentor will keep two (2) ML Points earned as long as the ID was in good standing when the points were earned.
- If an ID advances to a new Career / Achieved Title and is deactivated or terminated because the ID was not in good standing and was not in compliance with the Designer Agreement when the ML Points were earned, O2 reserves the right to make adjustments to the ML Points.
